AACD Update (Brooke Gladden):

The AACD Summer Conference will be August 9-11 at the Wigwam Resort. You must reserve a hotel room by July 19 and register for the conference by the end of July. On August 9, the AACD Board of Directors meeting will cover these items: company review, committee meetings and business meeting. At night, a silent auction will be held during the trade show mixer. On August 10, a series of panel discussions will be held on: surface-groundwater issues; conservation perspectives, & growing more food, conservation programs and local food, composting & donating and diversifying markets for agricultural producers. During lunch, Gloria Green, USDA Deputy Under Secretary for Farm Production and Conservation, will be the keynote speaker. At night, a local food, wine and beer tasting with a silent auction will be held. On August 11, Keisha Tatum (NRCS) will cover Resource Assessment and Local Work Groups. The Conserve AZ Portal and the Conservation Action Plan will also be discussed. The Gun Raffle was sold out. In terms of communications, AACD update emails are being sent out as needed. The newsletter is on a monthly basis. A ConserveAZ magazine will be published twice a year, printed copies for the Districts will be available at the summer conference, and now can be downloaded as a PDF. The website has been re-launched. Grant writing and management support services are available to the Districts. Stephen Williams will be attending the conference.

<u>State Land Reports:</u> The clerk reviewed the following Ed Center reports: Request for Funds Plans of Work, and Annual Reports. Dan Bell made a motion to approve the Request for Funds, Plans of Work, and Annual Reports. Bill Schock seconded it. The motion passed unanimously. 4-0
