Review/Approve 4/27/2022 Minutes: The agenda item was tabled until the July meeting.

<u>Complete 2022 Election Process</u>: The following Supervisors were selected as officers:

- Bill Shock nominated Stephen Williams to be the <u>Chairman</u>. Dan Bell seconded it. The motion passed 3-0, 1 abstained.
- Dan Bell nominated Bill Schock to be the <u>Vice-Chairman</u>. Andy Jackson seconded it. The motion passed 3-0, 1 abstained.
- Bill Shock nominated Dan Bell to be the <u>Treasurer</u>. Andy Jackson seconded it. The motion passed 3-0, 1 abstained.
- Bill Shock nominated Dan Bell and Stephen Williams to the <u>Appointed Supervisor</u> positions. Andy Jackson seconded it. The motion passed unanimiously 4-0. The Clerk will notify Jackie Thomas.

<u>Fox Neville-Johnson Resignation & Potential Appointees:</u> Per Stephen Williams, he received Fox's resignation notice on June 1. Her elected Supervisor position expires in 2024. He is looking for Cooperators to fill her position. Jim Koweek was suggested as a candidate but Dan Bell wondered if his annual monitoring contract would be a conflict of interest. Stephen will contact Jim Koweek to see if he is interested.

<u>State Land Reports:</u> The clerk reviewed the following documents with the Board:

- <u>District & Ed Center Request for Funds</u>: Bill Schock made a motion to accept the 3 Request for Funds documents. Dan Bell seconded it. The motion passed unanimously. 4-0.
- <u>District & Ed Center Plan of Work</u>: Bill Schock said that he is attending meetings for other groups. and will email the list to the Clerk. The Clerk will amend the District Plan of Work. No changes to the Ed Center Plan of Work were noted. Dan Bell made a motion to accept the 2 Plan of Work documents as amended. Dan Bell seconded it. The motion passed unanimously. 4-0.

<u>Disposition of NRCWAY Funds:</u> Per Stephen Williams, they had only 13 applicants; so, this summer NRCWAY camp was cancelled.
